

OVERVIEW OF RATES & FEES FY 2019 and FY 2020

- Every 3 years DC Water conducts a Cost of Service Study to ensure that charges are appropriately covering the costs.
- As a result, the Board proposed and approved a water and sewer rate increase of 13% for FY 2019 and 5% for FY 2020
- Combined rate increase for water, sewer and CRIAC lowered from 6.1% forecasted last year to 5.9%
- CRIAC decreased from projected \$28.41 in FY 2019 to \$23.00 in FY 2019 and \$25.58 in FY 2020.
- To achieve this decrease, the Board *reallocated* the CRIAC costs to the volumetric sewer rates.
- The \$40 million revenue collected from the Water
 System Replacement Fee (WSRF), which was designed
 to recover 1% of the costs for water line renewal and
 replacement, was used to in its entirety offset the utility's
 revenue requirements, resulting in a decrease in all water
 volumetric charges.
- Customer Metering Fee and WSRF will remain the same as FY 2018.

WATER SYSTEM REPLACEMENT FEE

MONTHLY FEE TO FUND THE ONE PERCENT (1%) RENEWAL & REPLACEMENT OF AGING WATER INFRASTRUCTURE FOR RESIDENTIAL, MULTIFAMILY AND NON-RESIDENTIAL CUSTOMERS.

THE FEE IS BASED ON METER SIZE AND AVERAGE FLOW.


DC WATER RATES & FEES CONTINUED

APPROVED SYSTEM AVAILABILITY FEE (SAF) | EFFECTIVE: JUNE 1, 2018

It is a **one-time fee** assessed to a property owner of any premises, building, or structure **to recover the cost of system capacity servicing, all meter water service, and sanitary sewer connections** which result
from renovation or redevelopment projects that require an upsized meter service connection to the
District's potable water system. The fee is assessed based on the peak water demand, excluding fire
demand, for new meter water service connection and renovation or redevelopment projects that
increase the peak water demand and associated SAF meter size for the property.



Projected Water & Sewer Rates


- Projected annual rate increase of 13% in FY 2019 and 5% from FY 2020 to FY 2027
- Projected water and sewer rate increase from \$9.70 to \$16.31/Ccf



^{*} Rates shown above reflect weighted water and sewer rates for the Residential customer category



Projected Clean Rivers Impervious Area Charge



- The projected charges displayed in the chart above are primarily driven by anticipated debt service costs necessary to support the \$2.6 billion Clean Rivers Project, which includes the federally mandated CSO-LTCP and the nine minimum controls program
- ◆ The annual Clean Rivers Project costs for the average Tier 2 residential customer (700 2,000 sq. ft. of impervious area) is projected to increase from \$276.00 in FY 2019 to \$437.52 in FY 2027
